**TUITION AND FEES**

- Grades 1-12                      \$3,600 Tuition
- Kindergarten                      \$2,150 Tuition
- 12.5% Tuition Reduction for 2<sup>nd</sup> and 3<sup>rd</sup> Child.
- No Tuition Reduction for 1<sup>st</sup> Child.
- No Tuition For 4<sup>th</sup> Child Or More.
- \$250 Enrollment Fee per family through April 20, 2010. \$350 Enrollment Fee per family after April 20, 2010.
- Building & Grounds Assessment, \$20.00 per child, per month (\$240/yr.).
- \$200 Book Fee per student in Grades 1-12, due by first day of school.
- \$150.00 Materials Fee per kindergarten student, due by first day of school.
- \$60 Technology Fee (Grades K3-12)
- All Enrollment Fees, Book/Materials Fees, TEC Fees and Tuition Due **MUST BE PAID PRIOR TO THE START OF SCHOOL.**
- New Student Discount--\$1,200 per student in grades 2-12..
- New Student Incentive for Current Parents- Parent may choose **ONE APPLICABLE DISCOUNT** (either the \$1200 new student incentive for grades 2-12 (up to a \$2,000 total), the 12.5% multiple child family discount, the 5% tuition reduction for payment in full by July 1, 2010, or the employee discount.)

**PAYMENTS**

- 5% Reduction for Tuition paid in full by July 1, 2010.
- **INCENTIVES WILL BE REVOKED IF YOUR ACCOUNT IS PAST DUE OR IF THE NEW STUDENT FAILS TO COMPLETE THE SCHOOL YEAR.**
- Monthly Tuition payments begin 6/1/10 and end 5/1/11.
- Monthly Tuition payments are due the **FIRST** day of every month.
- **\$25 LATE FEE WILL BE APPLIED TO ACCOUNTS FIFTEEN DAYS PAST DUE.**
- Accounts 45 days past due will result in dismissal of student(s) from The Carolina Academy unless balance due is paid in full.
- After dismissal, the account must be paid in full for the student to return to school.
- All 1<sup>st</sup> semester account balances must be paid in full for the student(s) to return for the 2<sup>nd</sup> semester.

The enrollment fee is nonrefundable. I further understand that in signing this enrollment contract for the coming academic year, I am agreeing to accept the rules and regulations of the Academy as stated in the Student Handbook and Policy Guide. I further understand that the school has the right to determine the class and work level to which the child will be assigned, to discipline or expel the child for any scholastic disciplinary reason or cause and the school shall be the sole judge of the sufficiency of such reason or cause; and to accept or not to accept this applicant as a student. Furthermore, I agree to the Policy of the Academy that no grades or transcripts will be released unless the family account has been paid in full. The Carolina Academy admits students of any race, color, and national or ethnic origin. This contract is binding in its entirety unless a release in writing is given by The Board of Directors of The Carolina Academy.
